THE DECLARATION OF PRINCIPLES OF THE REFORMED EPISCOPAL CHURCH AND THE 39 ARTICLES OF RELIGION, RECORDED ON PAGES 609-623 OF THE BOOK OF COMMON PRAYER ACCORDING TO THE USE OF THE REFORMED EPISCOPAL CHURCH (2005), SHALL CONSTITUTE THE OFFICIAL RELIGIOUS DOCTRINE OF COVENANT CLASSICAL ACADEMY. CCA MAKES NO APOLOGY FOR INSTRUCTION WHICH IS CONSISTENT WITH THE DOCTRINE OF THE REFORMED EPISCOPAL CHURCH. NEVERTHELESS, IT IS NEITHER THE PRACTICE NOR THE INTENT OF CCA TO DOGMATICALLY TEACH THOSE DOCTRINES THAT ARE DISTINCTIVE OF THE REFORMED EPISCOPAL CHURCH, BUT RATHER TO PROVIDE LATITUDE AND SHOW RESPECT FOR DIFFERING VIEWS ON ISSUES OF SECONDARY DOCTRINE. PRIMARY DOCTRINES SHALL BE DEFINED AS THOSE CLEARLY ARTICULATED IN THE CREEDS OF ORTHODOX CHRISTIANITY COMMONLY CALLED THE APOSTLES' CREED, THE NICENE CREED AND THE ATHANASIAN CREED.

### THE APOSTLES' CREED

I BELIEVE IN GOD THE FATHER ALMIGHTY, MAKER OF HEAVEN AND EARTH; AND IN JESUS CHRIST, HIS ONLY SON, OUR LORD; WHO WAS CONCEIVED BY THE HOLY GHOST, BORN OF THE VIRGIN MARY, SUFFERED UNDER PONTIUS PILATE, WAS CRUCIFIED, DEAD, AND BURIED; HE DESCENDED INTO HELL; THE THIRD DAY HE ROSE AGAIN FROM THE DEAD; HE ASCENDED INTO HEAVEN, AND SITTETH ON THE RIGHT HAND OF GOD THE FATHER ALMIGHTY; FROM THENCE HE SHALL COME TO JUDGE THE QUICK AND THE DEAD. I BELIEVE IN THE HOLY GHOST; THE HOLY CATHOLIC CHURCH; THE COMMUNION OF SAINTS; THE FORGIVENESS OF SINS; THE RESURRECTION OF THE BODY; AND THE LIFE EVERLASTING. AMEN.

### THE NICENE CREED

I BELIEVE IN ONE GOD THE FATHER ALMIGHTY, MAKER OF HEAVEN AND EARTH, AND OF ALL THINGS VISIBLE AND INVISIBLE. HE SUFFERED AND WAS BURIED, AND THE THIRD DAY HE ROSE AGAIN ACCORDING TO THE SCRIPTURES, AND ASCENDED INTO HEAVEN, AND SITTETH ON THE RIGHT HAND OF THE FATHER. AND HE SHALL COME AGAIN WITH GLORY TO JUDGE BOTH THE QUICK AND THE DEAD; WHOSE KINGDOM SHALL HAVE NO END. AND I BELIEVE IN THE HOLY GHOST, THE LORD AND GIVER OF LIFE, WHO PROCEEDETH FROM THE FATHER AND THE SON, WHO WITH THE FATHER AND THE SON TOGETHER IS WORSHIPPED AND GLORIFIED, WHO SPAKE BY THE PROPHETS. AND I BELIEVE ONE HOLY CATHOLIC AND APOSTOLIC CHURCH, I ACKNOWLEDGE ONE BAPTISM FOR THE REMISSION OF SINS, AND I LOOK FOR THE RESURRECTION OF THE DEAD, AND THE LIFE OF THE WORLD TO COME. AMEN.

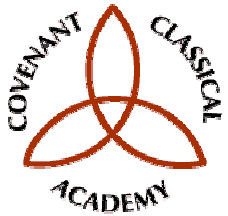
